




A note from the Treasurer...

It's been about a year since I clicked on the LGA logo in a chamber advertisement to see what The Lake Gaston Association did and stumbled across the "looking for a Treasurer" notice. It's been a year of learning not only about the organization, but also about Lake Gaston. The speakers were informative, and the topics are relevant to all property owners. I can't believe it took me 50 years to find this organization.

In the past year, the board has focused on fiscal responsibility, reducing administrative costs, and ensuring we have an accurate accounting system. We've implemented an electronic Bulletin, as well as an invoicing system, which certainly saved money.

Despite our cost savings, our reserves have been reduced by nearly \$13,000 (16%) over the last five years. Our administrative costs are at the bare minimum. Any further reductions would cut into the committee program budgets. Additionally, there are some enhancements and new programs the LGA would like to consider. To maintain the level of committee activities and prepare a balanced budget the board has decided we must make a minimal increase to our individual and our business memberships. We have not had a membership dues increase in **over 20 years!** The general membership will be increased by \$5 to \$30 per year, and the business membership will increase by \$10 to \$60 per year. In line with these increases, we are increasing the Lifetime membership to a one-time fee of \$300.



If you haven't actively participated in our monthly meetings or joined a committee, I highly recommend you do this. This has been a fabulous year of learning and community engagement and I encourage everyone to get involved as well as entice a neighbor to join. Treating Aquatic Vegetation on Lake Gaston

By the time you read this article the LGA Volunteer Survey of aquatic vegetation around the Lake Gaston shoreline will be well underway and hopefully nearing completion. The survey is conducted by volunteers who all have something in common – a desire to help maintain the water quality in Lake Gaston. The results of the annual survey are used by the Lake Gaston Weed Control Council (LGWCC) and North Carolina State University (NCSU) to help guide the next year's invasive/nuisance species treatment plan. Without the ongoing management and annual treatment of aquatic vegetation by the LGWCC and NCSU, there is the potential for invasive/nuisance vegetation to spread uncontrolled across the lake and connecting creeks. Currently, the species of greatest concern is lyngbya which is a blue-green algae that has toxic properties.

Work continues to halt the spread of lyngbya and bring it under control. In addition, while hydrilla is under control thanks to efforts of the LGWCC, NCSU, the LGA, and the many other supporting stakeholders, it is still lurking in many upper creek areas waiting for the opportunity to “breakout” and spread as it did in years past. Both lyngbya and hydrilla are listed in the 2015 North Carolina Aquatic Nuisance Species Management plan as higher priority concerns. Only continued vigilance and effort will prevent a future catastrophe in the form of uncontrolled invasive/nuisance vegetation spreading across Lake Gaston.

Property owners around the lake often ask how they can ensure shoreline around their property is considered by the LGWCC and NCSU for treatment of aquatic invasive/nuisance species. One way is to volunteer for the annual LGA Volunteer Vegetation Survey. The program always needs additional help to ensure that the lake shoreline is adequately assessed so priority treatment areas can be identified.

Unfortunately, the LGWCC does not have adequate resources to treat all locations across the lake and focuses on the highest priority areas based on collected data and scientific analysis. Dominion Energy, who manages the lake under its permit with the Federal Energy Regulatory Commission, has provisions to allow for the treatment of aquatic invasive/nuisance species by registered and licensed chemical applicators. In very specific instances Dominion may also allow the treatment of native vegetation that is inhibiting navigation on the lake to include permitted boathouse access. The hand removal of invasive/nuisance species by property owners is allowed, however precautions should be taken when removing lyngbya (e.g., prevent contact with skin and inhalation of dried vegetation particles). The Dominion Lake Gaston Reservoir Manager is the responsible party for making final determinations on authorized native vegetation treatment/removal. Lake Gaston property owners are reminded that chemically treating aquatic vegetation yourself is not allowed per the Dominion Shoreline Management Plan and may be a violation of the federal/state Clean Water Acts.

In closing, please keep in mind why it's to all our benefit to help manage invasive/nuisance aquatic vegetation on Lake Gaston:




2023 Annual Lake Gaston Vegetation Survey



Volunteers Needed!!

We hope you will consider volunteering for this event, and the best part is that you can choose any day(s) and any time(s) through October 31st to help with this project. This is an extremely important mission, and we need everyone's assistance to document the aquatic vegetation, both good and bad, along the entire 350 miles of shoreline – and yes, it all needs sampling. This survey is an important tool that determines how to keep Lake Gaston healthy for swimming, boating, fishing, and recreational enjoyment.

To Volunteer:

1. Please plan for this to take **only Four (4) to Six (6) hours** of time on the lake, on any day(s) and any time(s) of your choosing, through October 31st, using a boat, kayak, or jet ski.
2. The shoreline is divided into survey sections; volunteers can choose a section that is close to home.
3. Equipment to be provided:
 - a. Handheld electronic tablet for data collection.
 - b. Double-sided throw rake.
 - c. Plant ID booklet that will help identify the plants you will encounter.
 - d. Training is provided by several online videos that explain the vegetation survey in detail & provide tips for aquatic plant identification. There will be people available for questions.

Safety Committee...

Some weather forecasters are calling for a colder 2024 winter! It appears that the first part of winter will be mild. The coldest and snowiest part of the winter should be from mid-January onward. No matter if the forecast is correct or not, we understand that winter is on the way.

So if you are asking yourself why this may be important to you, there are a few things to consider. Are your smoke and carbon monoxide alarms working? You should replace smoke and heat alarms every ten years. Change carbon monoxide alarms every seven to ten years (depending on your model). Replace the batteries at least once a year.

When did you last clean your fireplace or wood stove chimney? A chimney fire is burning creosote, on the inner surfaces of chimney tiles, flue liners, stove pipes, etc. Cleaning them before the heating season prevents chimney fires (and potential house fires)!

If you do not live at the lake during the winter, you should plan to winterize your home. It is important to drain outside water lines to prevent freezing and splitting. Trim suspected limbs if they will fall on the house, and trim shrubs to allow clear views of windows and doors. Set your thermostats to a level that prevents freezing pipes. Winterize your water toys. Turn off external power outlets if not needed. Tell your neighbors how to reach you in case of an emergency and when you plan to return in the spring.



Have you ever wondered why Fire Prevention Week is held in October? The National Fire Protection Association is the official sponsor of Fire Prevention Week, which has been observed since 1922 to commemorate the Great Chicago Fire of 1871. Fire Prevention Week 2023 will be held from October 8-14, 2023, and the theme is "Cooking safety starts with YOU!"

Medicare Fraud Alert

I recently reviewed my health insurance Explanation of Benefits (EOB) report. To my surprise, I found that I received (never did) 6 months of diabetic care services. I contacted both my insurance company and Medicare to report the fraud of services. About four weeks later, I received two Medicare EOBs showing I received COVID home tests - from five different companies no less! I again contacted Medicare to report the fraudulent services. Today, one of the COVID companies notified me that they are investigating the fraud claim. This confirms that reporting fraudulent claims to Medicare results does yield results.

Somehow, my Medicare ID number was leaked (sold) to these fraudsters. **Lesson #1: Do not share your Medicare Number or other personal information with anyone.** Doctors, hospitals, and pharmacies need this information – nobody else without a valid requirement. **Lesson #2: Review your EOBs to ensure the information is correct.** You know when you went to your medical provider and what was done for you. If you detect incorrect information, the EOB explains how to report it. Medicare fraud and abuse can occur anywhere. This results in higher healthcare costs and taxes for everyone.

LGA Recipe Roundup...

Bacon Wrapped Kielbasa Bites

These brown sugar and mustard glazed kielbasa bites will be the hit of any holiday party you go to this year! They can be assembled earlier in the day and then glazed and baked right before serving.

Ingredients

- 1 lb. kielbasa
- 10 slices bacon
- 1 1/2 C brown sugar, packed
- 3 Tbsp stone-ground mustard
- 3 Tbsp white wine vinegar
- 1 Tbsp black pepper (adjust to taste)
- Cooking spray or parchment paper

Directions

1. Preheat oven to 375 degrees. Line a baking sheet with aluminum foil and spray well with non-stick spray, or put a layer of parchment paper down. The bites become very sticky when the sugar caramelizes and can be difficult to remove from the foil.
2. Cut kielbasa down the middle, lengthwise. Slice each half into 1-inch pieces, you should have about 30 pieces of kielbasa. Cut each piece of bacon into thirds. Wrap one bacon strip around each piece of kielbasa and secure with a toothpick. Set aside.
3. In a small saucepan, combine brown sugar, vinegar, mustard and pepper. Heat over medium, stirring occasionally, until the sugar is dissolved. (Can also be done in a microwave-safe bowl for 1 minute in the microwave.)
4. Brush the kielbasa with glaze and place on the baking sheet and bake for 40 minutes. Serve immediately.


